Except as otherwise noted, REDWOOD PLASTICS AND RUBBER CORPORATION (“REDWOOD PLASTICS AND RUBBER”) will warranty all REDWOOD PLASTICS AND RUBBER Redco™ Outrigger pads manufactured by REDWOOD PLASTICS AND RUBBER against breaking or cracking due to defects in material or workmanship. Subject to the limitations and exclusions described in this warranty, REDWOOD PLASTICS AND RUBBER will remedy defects in materials or workmanship by repairing or replacing, at its option, a defective product without charge for parts or labor. Taxes/duties paid and/or shipping costs from the initial purchase are non-refundable and not included within this warranty. In addition, REDWOOD PLASTICS AND RUBBER may elect, at its option, not to repair or replace a defective product but rather issue to a purchaser a refund equal to the purchase price paid for the product or a credit to be used toward the purchase of a new REDWOOD PLASTICS AND RUBBER product. This warranty covers only manufacturing defects and does not cover any damage caused by misuse such as bridging voids, neglect, accidents, abrasion, normal wear and tear or transport damage. To the extent permitted by applicable law, any implied warranties are hereby excluded. The warranty provided herein is limited to the value of the product. Manufacturing specifications are subject to change without notice. Inspect your product immediately after each use. No warranty is given for defects caused by normal wear and tear, misuse, scratches, accidents, or unapproved field modifications. No warranty is given for defects resulting from conditions beyond REDWOOD PLASTICS AND RUBBER’s control including, but not limited to, misuse, including the spanning of voids, overloading or actions in contradiction with REDWOOD PLASTICS AND RUBBER’s usage guidelines. Subject to the limitations and exclusions described in this warranty, REDWOOD PLASTICS AND RUBBER will remedy any breakage, cracking, or crushing damage by repairing or replacing, at its option, a defective product without charge for parts or labor. In addition, REDWOOD PLASTICS AND RUBBER may elect, at its option, not to repair or replace a defective product but rather issue to a purchaser a refund equal to the purchase price paid for the product or a credit to be used toward the purchase of a new REDWOOD PLASTICS AND RUBBER product. Said warranty is void if the posted crush rating, or allowable load rating is exceeded at any time after the initial purchase of the product. This warranty covers only breaking, crushing or cracking of the product under normal use, and does not cover any damage caused by misuse (such as exceeding the crush and allowable load limits), neglect, accidents, abrasion, normal wear and tear or transport damage. No warranty of any kind is provided in relation to the handles attached to the Redco Outrigger Pads including, but not limited to, any warranty with respect to defects in workmanship or materials contained within the handles.
